### Kids Corner Guidelines

1. Childcare is for members and paying guests **only** while using the facilities.
2. Children who are members may be brought in by another member or guest, **for an additional fee**, after filling out a release form with legal guardian's permission.
3. Children must be at least six weeks old, and no older than twelve years of age.
4. There is a **2 hour** maximum stay **per day** for each child.
5. The parent/guardian must show proof of childcare privileges at each visit, and remain on the premises while the child is the childcare.
6. The same parent/guardian is required to sign the child in and out unless staff is notified.
7. Please ensure that your child has been fed and changed prior to entering.
8. Please visibly mark all children's belongings.
9. No toys should be brought in with the exception of hand held games. This is at your own risk, Culpeper Wellness Foundation's Powell Wellness Center (PWC) will not be responsible for lost or damaged items.
10. No snacks or drinks with the exception of bottle or sippy cups may be brought into the Kids Corner. **PLEASE NOTE: No peanut products are allowed and please do not store peanut products in diaper bags.**
11. Children showing signs of illness (fever, vomiting, etc.) are not permitted in Kids Corner. No exceptions. Children **MUST** be free of symptoms (fever, vomiting, and diarrhea) for 24 hours prior to returning to Kid's Corner.
12. If your child(ren) is diagnosed with an illness that is contagious, please notify Kid's Corner immediately.
13. Kid's Corner staff cannot administer medication to any child(ren).
14. Good behavior is required. No running, hitting, biting, spitting or rough play is permitted. The Playroom is a special privilege for the PWC members only and may be terminated as a result of not abiding by the above mentioned guidelines.
15. Childcare is a privilege of membership and is subject to all other member rules and guidelines.
16. Guidelines can be reviewed at a future date and adopted when necessary.
